New Self-Quarantine Requirement for all inbound travelers who boarded from overseas

1. Regulation : Korean government is requiring all inbound travelers who boarded from overseas to mandatory quarantine for 2 weeks, regardless of region and nationality.
2. Effective date : April 4, 2020 ~ until further notice from the Korean Government
3. Regulations :
 - ✓ **You must have a place to stay** when you arrive, and the place of residence must have meet the following conditions.

If not, you will be subject to measures including deportation and entry ban in accordance with Immigration Act (Articles 11 and 46).

 - Type of residence which has a shared bathrooms, kitchen, and/or common areas is not acceptable.
 - Shared rooms in the dormitory/shared house is not acceptable.
 - If you already booked an individual(single) room in the dormitory/residence (which has a bathroom inside), you have to confirm with them whether they can deliver food to your room as you cannot leave the room for 2 weeks.
 - ✓ **If you do not have a place to stay upon your arrival in Korea**, you will be automatically place in facilities that have been prepared by the central government or local governments. The cost of the stay will be paid by the person being quarantined, and the cost is about 100,000 won (US\$90) per day.
 - ✓ Penalty : Failure to comply with mandatory home quarantine is punishable by imprisonment up to 1 year or a fine up to 10 million won

This regulation took effect as of April 8, 2020, and we do not know how long this will remain in effect.

한국 입국자에 대한 2주 자가격리 시행 조치

1. 시행일 : 2020년 4월 1일 ~ 미정

2. 시행내용 : 한국에 입국하는 모든 사람(한국인, 유학생 포함 외국인) 에게 해당 (출발국가 및 국적에 관계없이)되며, 한국 도착 후 2주간 자가격리를 의무화 함
